There was no update for the criteria for NCC not insisting on street lighting on the Broadland Housing development.

7. District and County Councillor reports.

There was no County Council Report but the clerk read a report from ward member P Cowen.

"There is not a great deal happening re Breckland, but I would ask that you advise members that we will be providing grants of up to £500 to parishes that wish to mark the platinum jubilee celebrations in June next year. Full details regarding this will be published nearer the time. In addition, we shall also be providing a checklist for parishes should they need to seek road closure notices and the like in connection with any celebrations.

As we are all too aware the HGV driver shortages combined with the fuel availability problems is having an adverse impact on society and Breckland is no exception. Thus, please bear with the Serco team as they undertake their refuse collection and recycling rounds. If a bin is missed, please use the report it function, on the website. Do please leave your bins out and they will be collected as soon as practically possible"

The meeting with the local farmers would be taking place before the next full council meeting on 22nd November.

No news from Highways yet.

There had been two people so far, declare interested in becoming part of the Community Speed Watch Team, six were required.

9.Planning Applications and updates.

3DC/2021/0246/DOC Brookside Farm Discharge of conditions. No comments required 3NM/2021/0079/NMA Non-material amendments to 3PL/2019/0474/F for the Broadland Development required no comments.

10. Highways Update

Councillor Thomas, reported that new kerbing and bollards had been installed at the Little Hockham Lane/Harling Rd junction.

The Rangers were due a visit. Reports to them included mud on the roads on Shropham Rd and Little Hockham Lane.

The kerbing damage by old school had been repaired.

The speed limit signpost at Little Hockham Lane has been fixed.

Road surface damage had been actioned for repair at the Watton Road/Shropham Road junction near the green.

The footpath by the school was due for works.

There were concerns mentioned of verge vegetation growth on the B1111 and the clerk would contact Larling Parish Council.

There was concern about loose barbed wire near Puddledock. This would be reported.

11. Finance.

A discussion on the 22-23 budget was had. There were concerns over a potential 50% increase in electricity costs for streetlights. This could mean a large increase in the precept, but more would be known by the next full meeting, after discussion with EON.
